## Brief report of Training on Child Protection Recognition and Response to So The Child May Live, HeXEN (UK) Kanti Children's Hospital, Nepal Paediatirc Society and Concern Parties

**Introduction:** This report is a summary of training at the Tribhuvan University Teaching Hospital(TUTH) on 31 March 2024 .This is part of an ongoing child protection training program supported by So the Child May live (STCML) and Health Exchange Nepal (HeXN) Uk and organized by Nepal Paediatric society (NEPAS) and Paediatric Nursing Association Nepal (PNAN) . This is the 17<sup>th</sup> training of this 3 year ongoing programme .It was hoped that this would help to recruit support for effective child protection processes in Kathmandu and periphery and more widely in the country as a whole in future.

**Background**: The Child Protection Recognition and Response (CPRR) one day course, which formed the backbone to this training initiative, is a UK based introduction to clinical practice in child protection that was developed about 16 years ago as part of a national response to the Public Inquiry conducted by Lord Laming in 2003 following death of Victoria Climbie in February 2000. The training course was sponsored by the Royal College of Paediatrics and Child Health (RCPCH). It was designed by paediatricians and specialist educators working for Advanced Life Support Group (ALSG) UK. The "Nepalisation" of the training, reported by DrRoun few year back, also means addressing and understanding the demography, epidemiology and public health needs of the children in Nepal to the practicalities of translation and interpretation of course materials and the language and the ideas behind them was need perceived. With considering these all, NEPAS had developed manual in Nepal with reference to RCPCH module and We are using this module. These session were organized by NEPAs for the paediatrician, nursing staff and post garaduate residents and post graduate nursing students working in paediatric OPDs and Wards of the different hospitals of Kathmandu and Dhulikhel .
